Cooperative ("BuyBoard") Contract #568-18

Proposed Date of Award: September 28, 2020

I concur with the recommendation of Jimmy Spivey - Chief of Police, and request permission to award a contract for Axon equipment, software, and services for the Police Department to Axon Enterprise, Inc. in the amount of \$2,696,206.47 over a five-year period, as provided in the attached proposal.

The above referenced equipment, software, and services have been competitively bid through BuyBoard Contract #568-18. The City of Richardson is a member of BuyBoard through its existing interlocal agreement for cooperative purchasing pursuant to Texas Government Code Section 791.025 and Texas Local Government Code Section 271.102.

Funding for the first year of hardware expenses in the amount of \$420,245.86 is provided from the FY 2020 Police Department Operating Budget. Annual software costs will be provided from the Information Technology Operating Budget. Future hardware expenses will be budgeted in subsequent fiscal years.

SUBJECT: Police AXON Purchases

In 2015, the Richardson Police Department (RPD) purchased the Taser X2 conducted electrical weapon (CEW) system from Axon Enterprise, Inc (Axon). In subsequent years (2016, 2017, 2018, and 2019), RPD entered into additional agreements with Axon and purchased Body Worn Camera, Patrol Fleet Camera, Evidence.com and Interview Room services. The first of these agreements is set to expire in 2021.

With the advancement of technology, Axon recently developed new hardware, particularly the next generation of both the Taser and Patrol Fleet Camera systems. In addition to the new hardware, Axon has developed additional software within the Officer Safety Plan (OSP) 7+ that allows the Department the ability to receive real-time services (such as alerts, live maps and streaming), to review body-worn camera policy performance in near real-time, and to automatically detect and track protected information with a redaction assistant.

To leverage current pricing discounts from Axon, the Department has renegotiated a new, comprehensive bundled contract to replace all existing agreements. In the new proposed purchase, RPD would acquire the following products/services:

- Newest versions of the Axon Body Worn Camera
- Newest version of the Axon Fleet, include new routers and complete installation
- Newest version of the Axon Taser (Taser 7)
- Auto Tagging of Video Evidence
- Axon Aware + advanced imaging and audio with real-time services
- Axon Signal Sidearm a sensor that alerts the body worn camera to start recording
- Axon AIR real-time services for Unmanned Arial Systems (UAS)
- Axon Records/Performance measures use of force policy performance and identify areas for training
- Axon Redaction Assistant automatically detects/tracks protected information in open records requests

The total payment for all Axon products and services over the 5-year contract would be \$2,696.206.47. The first year of hardware expenses, \$420,245.86, will come from the Police Department FY19-20 budget. Please let this memo serve as a formal request for City Council ratification of the above AXON purchases, which will enhance the Department's accountability, transparency and ability to protect the community.


